Any renewal form not completely filled out and/or not carrying the appropriate original signatures will be returned by NSAC for completion before processing.

Applicants are eligible for one half of the annual renewal fee if they have:

- A. Reached age 60 as of January 1 and held at least one or more certificates for 25 years, or
- B. Reached age 65 as of January 1 and held at least one or more certificates for 20 years.

Applicants over age 70 as of January 1 are exempt from further annual renewal fees but must continue to file this form annually to keep this credential in effect.
